



## One Year Limited Warranty

**Warranty.** All Marsh Monster Products (MMP) products purchased from an authorized MMP dealer come with a non-transferable One year warranty to the original, registered owner. MMP, LLC. ("MMP") warrants to the original end-user retail purchaser from an authorized MMP dealer ("Purchaser"), that this product will be free from defects in material and workmanship and will substantially conform to the specifications and descriptions in the Instruction Manual for One year after the date of original retail purchase, as supported by a dated receipt (the "Warranty Period"). This One year warranty provides Purchaser with specific legal rights. Purchaser may also have other rights, which vary from state to state or from jurisdiction to jurisdiction. Some states or other jurisdictions do not allow limitations on how long a warranty lasts so the above Warranty Period may not apply to you.

**Registration.** Purchaser must register their Nod Stopper within 30 days of purchase for this One year warranty to be valid. A warranty card will be included with every product package; the card must be completed and returned to MMP with a copy of the original sales receipt within 30 days of purchase. If the product is registered after the 30 day registration period, this One year warranty will not apply.

**Exclusions and Limitations.** This warranty does not cover paint scratches, cosmetic blemishes or other normal wear and tear. This warranty does not cover any failure of the product due to tampering, abuse, misuse, modifications, excessive wear and tear, improper setup, failure to maintain as recommended by MMP. MMP reserves the right to make product substitutions on warranty coverage for any reason, including, but not limited to, the lack of availability of a product, product parts or a specific colors.

**This warranty is in lieu of any other warranty, expressed or implied, including but not limited to any implied warranties of merchantability and fitness for a particular purpose. In no event shall MMP be liable for incidental or consequential damages or for any delay in performance of this warranty.**

**How to Obtain Warranty Service.** If, in MMP sole discretion, the product is defective or fails to conform to the warranted specifications, MMP will repair and/or replace (at MMP option) the product. This is your exclusive remedy for defective or non-conforming products.

## One Year Limited Warranty

3. The Dealer must call and obtain a Return Authorization Number ("RA number") prior to the product being shipped. The RA Number must be clearly placed on the outside of the shipping box.
4. The product must be packed with a copy of the dated purchase receipt, dealer address and telephone number, customer information (including name, address and phone), explanation of the issues, RA Number and any other information MMP requests as part of the return authorization process (such as any return authorization form you receive) in a sturdy packing material.
5. MMP will provide customer with ship location.
6. Purchaser must pay for any shipping and insurance charges to deliver the product to MMP. Purchaser assumes all risk of loss and/or damage to the product until it arrives at MMP. MMP will pay for ground shipping of the new or repaired product back to Purchaser at the address provided by Purchaser and assumes all risk of loss or damage to the product until it arrives at the specified address. Purchaser must request and pay for any other shipping method. If MMP reasonably determines that the product has failed to meet the standards of the warranty, Purchaser will be liable for the cost of return shipment to Purchaser. MMP may require payment of such costs before returning the product. The risk of loss or damage shall remain with Purchaser, not with standing MMP's possession of the product. If the product is shipped without an RA# to MMP, the shipment may be refused.

**Applicable Law.** Where not prohibited by the law of the jurisdiction in which the product is supplied to you, the laws of the State of Michigan and of the United States of America will govern this limited warranty, without regard to conflict-of-law principles.
